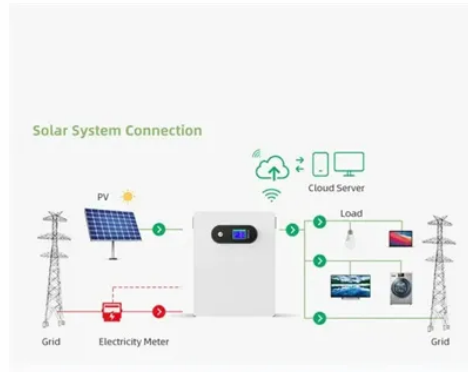




# How much do photovoltaic panels pay farmers
